NOTICE: REGULATIONS AND GUIDELINES FOR HOLDING OF NCFP-SANCTIONED TOURNAMENT 2022

To all over-the-board tournament organizers who wish to have their events sanctioned by NCFP, please be guided by the following:

Effective immediately, all National Chess Federation of the Philippines (NCFP) members and organizers of NCFP-sanctioned tournaments shall comply with the following regulations:

- 1. To give an ample time, six (6) months from now, all NCFP sanctioned tournaments will be FIDE Rated. Hence, it is mandatory for its participants to be NCFP Members.
- 2. The organizer of an NCFP—sanctioned tournament must be a chess club or organization duly affiliated and in good standing with the NCFP.
- 3. The Organizer/Chief Arbiter must submit the following details to ncfpevent@gmail.com at least **10-14** working days before the actual event.

All Tournaments (FIDE - rated)

Prior the tournament:

a) FRS Document: download document here

b) Marketing materials (such as posters etc.) Contact Person details to be added in NCFP Calendar for Other sanctioned events

c) Attach a copy of sanction fee payment.

Standard Tournament: 4,000.00 Rapid Tournament: 1,000.00 Blitz Tournament: 500.00

Post tournament:

Chief Arbiter must submit the ff: **not more than 2 days after the event**:

- a) Tournament file with correct details of players who have no FIDE ID. Make sure to properly input the dates of birth and spelling of names are correct for accurate FIDE ID application.
- b) Submit the TUNx file for rating adjustment purposes. Results must be uploaded to chess-results.com.
- 4. Arbiters in all NCFP-sanctioned events must strictly be duly licensed by the Philippine Arbiters Chess Confederation (PACC Inc). The arbiter shall endeavor to post all pairings at www.chess-results.com before each round unless for causes beyond his control such posting is not possible.

- 5. The NCFP shall sanction only one rapid tournament in a city or municipality per day, unless the second organizer can show that the holding of a second tournament in the same city will not affect the participation in the first tournament. For this purpose, Metro Manila shall be considered one city.
- 6. **NCFP** members shall not be allowed to participate in tournaments that are not sanctioned by the NCFP. Violation by individual (titled/non-titled) members, arbiters, or organizer of this rule shall be cause for revocation or cancellation of their membership with the NCFP.
